協定校——Wageningen University, The Netherlands

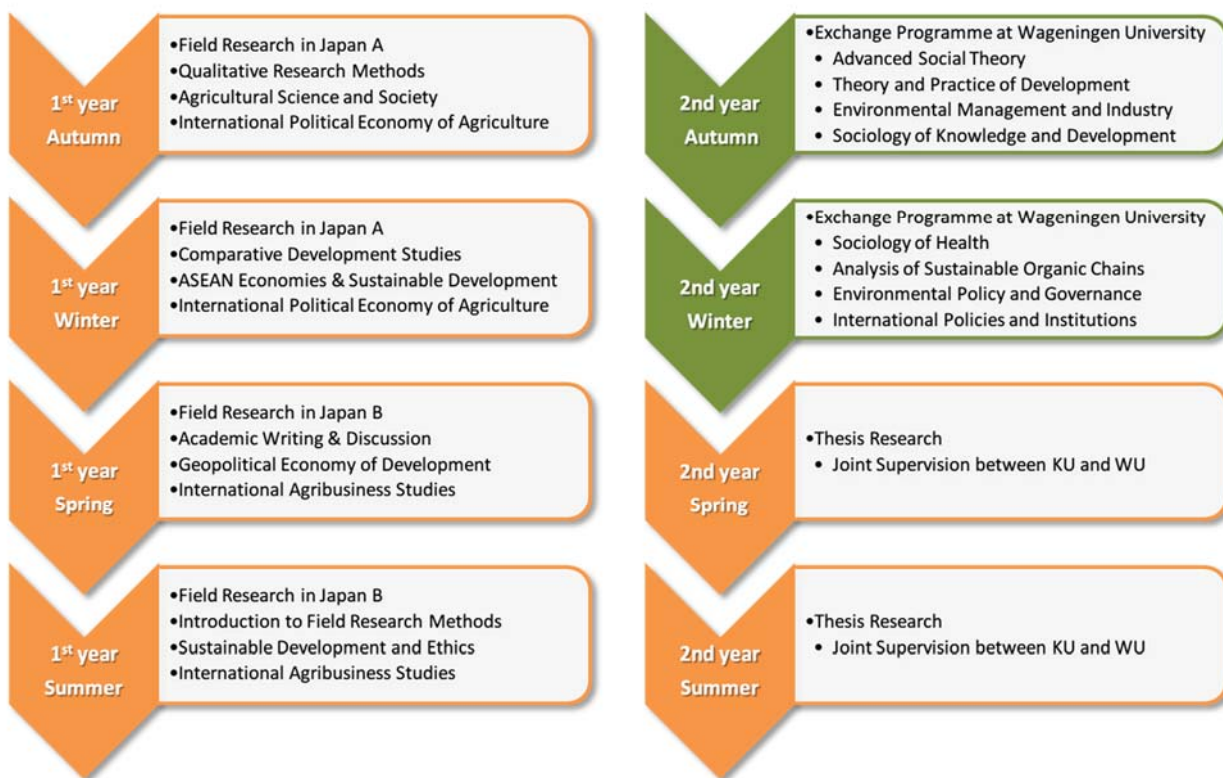
基本的な考え方——JDを想定。それに準じた内容で修了認定を行う。

- 修士課程＝30単位、論文研究を除く22単位のうち8単位をWageningen大学の開講科目から取得、共同論文指導、共同口頭試問。
- 博士課程＝24単位、論文研究を除く8単位のうち4単位をWageningen大学の開講科目から取得、共同論文指導、国際学会で2本以上を発表、共同口頭試問。

今後の日程——3月15日に双方窓口教員及びWageningen School of Social Sciences国際交流担当教員とMTG予定

- Students of this track will be encouraged to take an exchange programme (MSc in International Development Studies / PhD in Rural Development) at Wageningen University, the Netherlands, one of the centres of excellence in the field of environmental, agricultural and food-related sciences.
 - *Wageningen University & Research Centre (WUR) is one of the world's leading education and research centres in the plant, animal, environmental, agrotechnological, food and social sciences. WUR is ranked 77th of all universities worldwide and 22nd for life sciences (THE World Reputation Rankings 2014), the second of the 150 best universities in the world in the field of agriculture and forestry (QS World University Rankings 2014), and the best university in the world in agricultural research (NTU Ranking 2014). Wageningen University, part of WUR, also has an excellent international reputation.*
 - *One of the five departments, Department of Social Sciences, consists of six Sub-departments: Sociology & Anthropology of Development; Sociology & Governance; Communication, Philosophy and Technology; Economics; Business, Consumer and Competence Studies; and Management Decision Support. First two sub-departments, including 7 chair groups such as Rural Sociology, Sociology of Development and Change, and Environmental Policy, among others, are our close counterpart.*
 - *Researchers, including PhD candidates, based in 26 chair groups of Social Sciences and Environmental Sciences, participate in the Wageningen School of Social Sciences (WASS) and promote research that increases the understanding of social processes and design practices around challenges in the domains of food, agriculture, environment, health and development.*
 - *For Master programmes, International Development Studies, Development and Rural Innovation, Applied Communication Science, and Management, Economics and Consumer Studies in social sciences and some others in environmental sciences could be our counterpart, but students at Wageningen University are usually encouraged to pursue interdisciplinary studies including natural sciences.*
- Requirements for issuing a Joint Certificate (Masters) include: **obtaining minimum 24 ETC from participating in the exchange programme at Wageningen University (equivalent to 8 credits: the maximum 8 credits can be included in the minimum 30 credits required for master's graduation); completing a thesis under joint supervision; and presenting a thesis at a joint workshop either in Kyoto or Wageningen.**
- Requirements for issuing a Joint Certificate (PhD) include: **obtaining minimum 12 ETC from participating in PhD training courses offered by WASS (equivalent to 4 credits: the maximum 4 credits can be included in the minimum 8 credits that need to be obtained from Advanced A and B); presenting at least two papers at international scientific conferences; completing a thesis under joint supervision; and presenting a thesis at a joint workshop either in Kyoto or Wageningen.**

分野——モジュール 2 (→ Track#2) Business History & Industry Policy Studies

- Glasgow 大学——修士 DD を目指すも、その過程で欧州 4 大学共同学位 Erasmus Mundus に non-EU Associate Partner として参加すると同時に、条件が整えば Joint Certificate Programme を設置する可能性あり。
- Copenhagen Business School——当面は DD・JC とも目指さず、通常の交流協定ベースの連携を進める。

分野——モジュール 5 (→ Track#3) Developing & Emerging Economies Studies

- 中国人民大学——修士 DD を予定。
- Chulalongkorn 大学——修士 DD を目指す。

分野——モジュール 3 (→ Track#4) International Trade & Financial Studies

- 国際連携は当面考えていない。

分野——新規* (→ Track#5) Business Management & Accounting Studies

- 国際連携は当面考えていないが、Singapore Management 大学、KU Leuven、Koç 大学等との交流協定ベースの連携を強める。

*モジュール 4 はモジュール 2 (Track #2) と新規 (Track #5) へ統廃合

これらの Track でも修士認定証を発行することになれば、Track#1 の JD を想定した JC の要件を緩和するか、もしくは別のカテゴリーで修士プログラムを作成するかで対応する。

- Heidelberg 大学との修士 JD を最優先課題として取り組んでいる。

また JD に参加できない学生のために、本学単独での認定証を授与することを検討している。認定のためには、2015 年 10 月から新規開講した科目群 Courses for Asian & Transcultural Studies（略称 CATS。2015 年度後期 8 科目、2016 年度は前期・後期の合計で 22 科目）を利用し、文学研究科の大学院生で、TOEFL iBT のスコアが一定条件を満たし、かつ CATS から 4 科目 8 単位（コア科目 Introduction to Transcultural Studies を必修とする）以上を取得した者に対して、通常の修士修了にあわせて、CATS 認定証を授与することを検討中である。
